





President's Report





The WNF had a great year that resulted in the publication of the Health Technology Assessment on Naturopathy.

The WNF worked with the global naturopathic community over the last five years to compile a Health Technology Assessment (HTA) on Naturopathy which provides an evidence-based summary of naturopathic practice and the safety, economics and effectiveness of naturopathic care.

The scope of the HTA was informed by research conducted by the international naturopathic community over the last thirty years encompassing over 2000 peer-reviewed scientific articles of which more than 300 clinical studies involving over 100 different health populations are outlined in the HTA. The WNF conducted 7-international surveys of naturopathic organizations, naturopathic educational institutions and the global naturopathic workforce as part of the background for this important project.

The HTA is a 750 page book with <u>41 Chapters</u> titled *Naturopathy*, practice, effectiveness, economics & safety. Naturopathic doctors Amie Steel, Jon Wardle and myself had the privilege of being the editors for the HTA. We would like to acknowledge the 51 naturopaths/naturopathic doctors who contributed to chapters of this HTA (See Appendix IV) and to those that reviewed sections

of the HTA (See Appendix V). We would like to thank <u>Naturopaths And Herbalists Association Of Australia</u> (NHAA) for their generous support in helping to fund this project.

Other key WNF activities in 2021 included:

• 2021 Special Meeting: Due to global travel restrictions, the WNF held a virtual Special Meeting on May 19, 2021 in place of an Annual General Meeting. Representatives from 21 countries, 48 members in all, joined via ZOOM. In addition to the usual business of an Executive meeting (approving new members, committee up-dates), attendees welcomed three new executive members, reviewed the activities in the last two years, approved the organization's financial report and accepted a new Strategic Plan. Based on the successful completion of the 2019-2021 plan, the Strategic Plan sets targets for membership numbers, sponsorship dollars as well as the launch of a new Environmental Health website, and establishing new external alliances.

President's Report (cont'd)

- Rapid Reviews: Interest in the WNF's <u>COVID-19 Rapid Review Special Issue published in Advances in Integrative Medicine</u> continued into 2021. In total eleven <u>Rapid Reviews</u> have been completed. The report from Amie Steel provides further details on the impact of the Rapid Reviews.
- Educational Review: The detailed review of the naturopathic educational programs around the world resulted in two publications, the WNF Naturopathic Education Report and the WNF Technology Enhanced Education report. These reports will be a valuable resource for the profession.
- Environmental Pollutants website: In early 2021, the WNF launched its website on Environmental Pollutants. The focus on this website is on public education and on increasing the public's awareness of the role of naturopathic practitioners in this addressing this health concern. Moira Fitzpatrick's update provides more details on the success of this initiative.

The productivity and the strength of the WNF is very much due to the support and engagement of its members. Thank you to everyone that has contributed to the WNF projects.

Membership



Membership and sponsorship expansion continued to be a WNF focus in 2021.

The WNF offers the following membership categories with the respective criteria:

- Full Members, comprised of the national naturopathic organization in a country.
- Educational Members with a minimum educational standard according to the WHO Benchmarks in Training of Naturopathy or the highest educational standard offered in their specific country.
- Associate Members that represent a regional naturopathic association
- Non-Profit Sponsors and Corporate Sponsors in line with the ethical criteria of human health and environmental health.

Membership growth is the core activity of the Membership Committee in order to expand and unite the profession globally.

The WNF has currently 67 members (35 Full Members, 10 Associate and 22 Educational Members) and 21 sponsors (9 Non-Profit and 12 Corporate Sponsors).

In 2021, the Membership Committee received a high number of educational applications. After a thorough review, only a few have been approved. The WNF Membership Committee worked with the Educational Committee to create an updated WNF Educational Membership application that was more reflective of the criteria required for WNF membership. The new application was approved by the WNF Executive in February of 2022.

The committee also received applications and expressions of interest in joining the WNF from countries where naturopathic associations do not exist. We assisted these countries in establishing a national naturopathic association, including providing bylaw information as well as the requirements for founding associations or federations.

Educational





Part of the mission of the WNF is to support naturopathic accreditation and the highest in naturopathic educational standards in each country. There has been a tremendous amount of research into naturopathic educational programs over the last five years in order for the WNF to codify the status of naturopathic education globally. We would like to thank all the naturopathic schools and associations that responded to our surveys and requests for information.

In March of 2021 the <u>WNF Educational Committee</u> published the <u>WNF Naturopathic Educational Program Report</u> and the <u>WNF Technology Enhanced Learning Policy</u>. The Report provided the foundation for the chapter in the HTA on the Educational Standards for the Naturopathic Workforce. The key points that were highlighted include:

- Of the 131 naturopathic educational programs globally 38% reside in the region of South-East Asia, 27% in the European region, 22% in the region of the Americas, 9% in the Western Pacific region and 4% in the African region.
- There are two main types of naturopathic educational programs emerging globally – the doctorate-level training programs at over 4,000 hours – which currently represents 52% of all programs – and the practitioner-level training programs at 2,500 hours.
- There is diversity in naturopathic educational programs in some WHO Regions, especially Europe and Latin America, though there is a trend towards higher naturopathic educational programs globally.

In response to numerous applications for educational membership with the WNF that the WNF Membership Committee was not able to approve, in 2021 the WNF Educational Committee worked with the Membership Committee to create an updated WNF Educational Membership application that was more reflective of the criteria required for WNF membership. The new application was approved by the WNF Executive in February of 2022.

Initiatives of the WNF Educational Committee in 2022

The focus on increasing naturopathic educational standards globally is coming at a time when there is a tremendous drive to integrate technology-enhanced learning into higher educational programs across all sectors.

Educational (cont'd)

To support the mission of the WNF, the initiatives planned for the WNF Educational Committee in 2022 include:

- Further outline the breakdown by naturopathic educational curriculum for a 2500 hour program and a 4000+ hour program.
- To provide opportunities for naturopathic educational institutions and key-stakeholders to discuss
 the impact of technology-enhanced education on naturopathic programs and on the success of the
 naturopathic workforce.
- To compare the core competencies outlined in the four naturopathic accreditors (North America:
 Council on Naturopathic Medical Education (CNME), India: Central Council for Research in Yoga &
 Naturopathy (CCRYN), Western Pacific: Australian Register of Naturopaths and Herbalists (ARONAH)
 and Switzerland: Organisation der Arbeitswelt Alternativmedizin Schweiz (OdA AM))

Professional Mapping



The aim of the <u>Professional Mapping Committee</u> is to examine regulatory and education infrastructure and policy frameworks that impact the development of naturopathic medicine internationally. There are four phases to this case study.

Phase one was a cross-sectional survey of 65 global naturopathic organizations [educational institutions, professional associations and regulators of naturopathy] from 29 countries, which has been completed, published in February 2021 and reported on in the WNF 2020 Annual Report.

Phase two analysis is near completion and involves analysis of more than 1,000 organizational documents in seven languages. From

documents provided, combined with answers given to the previous survey, 15 countries were identified as representative of the range of regulatory, education and practice frameworks across all stages of development for naturopathy globally. In so doing, results will be applicable across the breadth of countries surveyed. Working with documents in multiple languages has been time consuming and challenging. We are very grateful to naturopaths across the globe who have assisted with translation – such as study could not be achieved without collaborative efforts.

Phase three involves on-line interviews with national naturopathic leaders from these 15 countries about the challenges and opportunities naturopathy faces in these countries. Invitations have recently been sent to the professional organizations by World Naturopathic Federation and we encourage participation as the findings from this research will inform discussions with WHO and provide data to support discussions with all national governments in which naturopaths practice irrespective of the stage of development. These interviews will take place in the second-half of 2022.

Phase four will examine selected legislation from the 15 countries and the impact on the naturopathic profession. This project is enabled by participation of naturopathic education and professional association members of WNF from across the globe.

Research



The focus of the <u>WNF Research Working Group</u> is to support the codifying and synthesizing of existing knowledge, the generation of new knowledge and the dissemination of this knowledge to the wider clinical and research committee. The naturopathic profession is a leader in research supporting Traditional and Complementary Medicine practice and has been active in developing research capacity in other health and medical areas beyond naturopathy / naturopathic medicine.

In 2021 the WNF Research Working Group focused primarily on the Health Technology Assessment on Naturopathy.

Naturopathic Research Resources Available

Research resources that have been compiled by the WNF Research Working Group for both the naturopathic community and the greater healthcare community include:

- <u>Health Technology Assessment on Naturopathy (HTA)</u> a 750-page resource that provides an evidence-based summary of naturopathic practice and the safety, economics and effectiveness of naturopathic care.
- <u>Naturopathic Research Institutions</u>: the WNF website lists over 25 universities, spanning five WHO Regions, with naturopathic-focused research centers.
- <u>Databases for Traditional and Complementary Medicine Research</u>: the WNF website lists key databases that provide indexed research articles for T&CM professions, such as naturopathy.
- <u>Naturopathic Peer-Reviewed Journals</u>: Naturopathic research papers appear in a range of main-stream journals, but there are also over 20 journals that tend to focus on naturopathic research.
- Research Writing Tools: The WNF website contains guides on writing different types of research papers such as case studies, systematic reviews and meta-analyses.

2022 Focus for the WNF Research Working Group

The initiatives planned for the WNF Research Working Group for 2022 include:

• The WNF with the support and guidance of the Canadian College of Naturopathic Medicine (CCNM) will be conducting a live review highlighting the systematic reviews of natural health products that have been researched in response to the pandemic. The live review will be hosted on the WNF website as of the end of May 2022 and will be updated monthly. It will include nutraceuticals and herbal products used in the prevention or treatment of COVID, in the management of long-haulers and/or in the treatment of vaccine-related issues.

Research (cont'd)

- The White Paper Committee is a sub-committee of the WNF Research Working Group and it will be focused on the production of 5 White Papers including: non-communicable diseases (NCDs), hypertension, Type 2 diabetes, mental health and environmental health.
- The <u>International Research Consortium of Naturopathic Academic Clinics (IRCNAC)</u> will be revitalized in 2022 with the aim of increasing naturopathic research capacity internationally and supporting research projects focused on naturopathy and naturopathic care. Stay tuned.

Rapid Reviews



Interest in the World Naturopathic Federation's COVID-19 Rapid Review Special Issue published in Advances in Integrative Medicine in 2020 has continued into 2021. Two additional rapid reviews started as part of the WNF project but not completed in time to publish in the Special Issue have since been published. The first, a rapid review of honeybee products (e.g., honey, propolis) was published in January 2021 in the journal Integrative Medicine Research. The second is the completed rapid review of zinc of which the team published in draft in the Special Issue with the final version published in BMJ Open this month. Both reviews are among the top 5% of research outputs attracting interest globally, through engagement on Twitter and publication in online news outlets.

Our original Rapid Reviews have also continued to generate interest in the research community, including:

- Vitamin D review: used to inform a detailed <u>meta-analysis</u> of the potential for vitamin D supplements to treat SARS-CoV-2 positive patients
- <u>Echinacea review</u>: informing a recent <u>blog</u> in Medical Daily "12 Best Immune Booster Vitamins and Supplements for COVID-19 and Flu", and included in a research <u>article</u> overviewing potential therapeutic and preventive interventions for COVID-19
- <u>Multivitamins review</u>: referenced in a <u>study</u> that found an association between women taking multivitamins and their likelihood of SARSCoV-2 infection.
- <u>Elderberry (Sambuccus nigra) review</u>: identified in a <u>study</u> reporting the development of a new natural health product to boost immune competence and sports performance.
- Quercetin review: included in a <u>study</u> of potential immunonutrientbased supplements treating COVID-19 via ACE-2 inhibition

When combined with the reach and impact of the Reviews in 2020, this last year of activity shows how our earlier efforts continue to contribute to the global response to COVID-19.

Communications



The WNF <u>Communications Committee</u> is focused on the promotion of the naturopathic profession internationally, and ensures that the naturopathic profession is part of the global health conversation. Committee initiatives also support members in promoting the profession in their countries and provided resources for social media.

The main social media focus in 2021 included:

- · New member welcome
- · Research articles promotion
- Promoting of WNF member's events and activities
- A strategy for the launch of the Health Technology Assessment Naturopathy in 3 phases
- The Environmental Health Campaign

The WNF launched the Environmental Health campaign to educate the public on risk factors environmental toxins have on human health. Resources for that campaign included an <u>animated video</u> about how to limit exposure of environmental pollutants. The video is available in 5 languages on YouTube.

The Environmental Health campaign was supported by a <u>website</u> created by the Environmental Health Committee. The Communications Committee created a social media campaign promoting the website and videos with two posts per week for a 6 month period. Our marketing staff has created great images to draw attention on social media.

The Environmental Health Campaign was truly a team project that reached a worldwide audience of over 50,000 people, through more than 240 posts.

Thank you to the generous donors who supported the Environmental Risk Factors Campaign. Your support helped underwrite the cost of the animated video and website.

The WNF social media includes a <u>LinkedIn</u> account, a <u>Facebook</u> site, <u>Twitter</u> – an <u>Instagram</u> account and a YouTube channel.

To date the WNF social media has 8,215 subscribers in total and reached over 130,000 people with 480 posts in 2021.

Environmental Health



The <u>WNF Environmental Health Committee</u> is focused on educating the public on the impact of environmental pollutants on health.

Throughout 2021, the WNF Educational Health Committee in collaboration with the WNF Communications Committee began a social media campaign to educate people about toxic pollutants, what are they, how they affect health and what you can do to protect yourself. The social media initiative resulted in 252 posts that have reached over 54,557 individuals. The areas of focus that have currently been highlighted include food, kitchen products, microbiome and electromagnetic frequencies (EMF).

The Environmental Health Committee will continue to work on updating new topics on the WNF Environmental Pollutants website with the aim of reinitiating a social media initiative in the fall of 2022.

The Environmental Health Committee is on a mission to educate people across the globe so we can protect ourselves and our planet. REGIONAL SUPPORT GROUP UPDATE

Latin America



In 2021 the WNF Support Group for Latin America organized a Latin American Meeting of Naturopathy which took place on November 29, 2021, with 27 speakers from ten countries participated in the online modality.

The general objective was to collaborate actively with the World Health Organization and the WNF in the Americas region, promoting the incorporation of a network of strategic alliances of Naturopathy that strengthens the formulation and exchange for the implementation of regional policies in health promotion, collaborative work and educational environments. In turn, this meeting sought to contribute to the achievement of the Sustainable Development Goals as part of the strategy of the Pan American Health Organization through the contribution of traditional and complementary medicines in the region of the Americas.

The event's opening was attended by representatives from WNF, Pan American Health Organization, and the presidents of the several national associations from Brazil, Chile, and Uruguay, as event organizers.

We had a lecture and five round tables. The opening conference, given by Tina Hausser from WNF, was about the global vision of Naturopathy. Following this, the round tables discussion addressed:

- · The regulatory frameworks of naturopathy in the region.
- The issue of Naturopathy in Health Systems in Latin America.
- · Research in Naturopathy.
- Naturopathic teaching experiences in Latin America and the Caribbean and
- Naturopathy in the current global health situation.

By discussing educational standards, regulatory frameworks, naturopathy in health systems, and the current global health situation, the meeting strengthened the links of naturopathy in the region. For this year, two thousand and twenty-two, we will continue to work on these topics and write the history of Naturopathy in Latin America.

REGIONAL SUPPORT GROUP UPDATE

Western Pacific

Australia

Another recent update with regards to the Review of Natural Therapies Review and they expect an outcome before the end of the year. A positive outcome will mean a change implemented in 2023. Australia is hosting the launch of the HTA for our region on March 25th, at parliament house in Sydney, NSW. NHAA is focused on the guest list for the invites – aiming to get as many press, politicians, academics, industry leaders there as possible.

Hong Kong

Association does monthly zooms. Annual meeting will be held in March. Practitioners are navigating the current situation in Hong Kong.

Japan

The situation in Japan is not much different from last year as they are currently taking measures against the new corona. Association has translated the HTA. By the end of March, expect a change in the situation in Japan, so the aim will be to give explanations and materials to each political party in Japan. They would like to see it reflected in Japan's national policies.

New Zealand

Starting a Journal Club with members, and mentoring for new graduates. Applied to join AHA at the end of last year and may hear back next month. All for non-regulated allied health, massage has been able to join. Have to have standards in place. AHA are in touch with the government a lot, with regards to COVID and regulation. In 2019, members voted for 4-year degrees and the ARONAH standards. Colleges in NZ need to be in and operational by 2025.

Africa

Ghana faces challenges of funding and promotion of trust in naturopathic medicine.


Nigeria explained their governments legislative approach to naturopathy. They have a state system whereby federal government providing guidelines, with each state implementing their own rules within the federal government legislation. Naturopathy is officially recognized as a profession under complementary medicine. Complementary medicine has only one federal appointed seat at the Medical and Dental Council. The seat is currently occupied by another complementary profession.


South Africa has an established Naturopathy profession in terms of legislation and council representation, but this has been separated from traditional medicine. Ways were discussed to combine naturopathy with what is a large existing traditional medicine patient base in Africa.


